 - B. Dick Dolgonas, via Zoom, addressed a concern that he felt interfered with the quality of life in Roseburg and asked if the City could begin an aggressive action to ensure motor vehicles meet the letter and intent of the noise ordinance.

 - A. Ashley Hicks, via emailed comment, disagreed with the Mill Street location for a City Navigation Center and suggested city property on General Avenue.
 - B. Manya Nicholson, via emailed comment, offered no objection to the location, it was near the core population, was an existing building, fenced parking lot and near markets already frequented.
 - C. Betsy Cunningham, via emailed comment, said Housing First Umpqua supported the purchase of UCAN's Mill Street office for the Navigation Center and it would be a location where services could be accessed more than what was currently available.
 - D. Bernie Woodard, via Zoom, supported the Navigation Center, but did not want the Mill Street location. He provided concerns regarding homeless in the downtown areas and asked Council to allow more public input and be frugal with funds to avoid having a building that was not useful.
